Paragraph 1

In the Memorandum of Understanding for Establishment of the Public Administration Reform Fund between the United Kingdom Department for International Development, the Swedish International Development Cooperation Agency, the Ministry for Development and Cooperation of the Netherlands, the European Commission Delegation in BiH and the Council of Ministers of BiH, the Government of the Federation of BiH, the Government of the Republic of Srpska, the Government of the Brčko District of BiH and the Ministry of Finance and Treasury of BiH, in the "Introductory Paragraphs: Considerations", in the item 1, behind the words "the Ministry of Foreign Affairs of the Kingdom of Norway" a comma shall be added and then the words: "the Ministry of Foreign Affairs of Denmark".

Paragraph 2

In the paragraph 3 in the item 19, at the end of the text, the following text shall be added and shall read: "The Ministry of Foreign Affairs of Denmark shall make an investment in the PARF in the total amount of DKK 28.25 million (approximately EUR 3.76 million by the exchange rate on the day of the transfer), starting from 2014, in accordance with the dynamics of payments approved by the Ministry of Foreign Affairs of Denmark. The funds shall be spent successively, in accordance with the dynamics of approval of the terms of references for the various projects to be financed by the PARF JMB. The Embassy of Sweden in Bosnia and Herzegovina shall act as a delegated partner on behalf of the Ministry of Foreign Affairs of Denmark."

Paragraph 3

The Annex IV to the MoU shall enter into force for the given donor on the day that donor signs it, after it has been signed by the Council of Ministers of Bosnia and Herzegovina, the Government of the Federation of Bosnia and Herzegovina, the Government of the Republic of Srpska, the Government of the Brčko District of BiH and the Ministry of Finance and Treasury of BiH.
